- a. Plan Commission approved Weigel rezone.
- b. Garbage Steve reminded people that the tire recycling will take place on April 29 from 8a-3p. McMillan is co-host and we are looking for volunteers to work that day.
- c. Library Dan attended Ad Hoc library committee meeting regarding the joint library agreement which ends September 2023. Looking to utilize a three-year rolling average to smooth out costs.
- d. Buildings and Grounds Lots of things to do this spring. Obtaining mowing quotes as well as quotes to help keep the ball diamond, volleyball court, and playground tidy.

- e. Highway Pat is filling potholes. There was a partial washout and blacktop collapse on Birch Tree Road, this should be repaired.
- f. Fire Department 4 EMS calls, 1 Wood County MABAS call. Two new AED devices have been put into service.

#### 8. CLERK REPORT

- a. Clerk noted zoning permiton Eau Pleine and County Road E
- b. DOT grant was submitted on March 20, 2023
- c. **MOTION** approve checks 19391-19444 plus electronic transfer 20230301-20230309 and also three additional checks for Waste Management, Cyber Insurance renewal, and First State to retire the breather loan; Michalski/Seyfert; all ayes
- d. Year to date budget to actual through April 10, 2023 was presented

### 9. TREASURER REPORT

- a. The treasurer notified the Board that both the interest rate for both the ARPA and Tax Savings Money Market accounts were increased to 3%.
- b. \$700 will be moved from general to parks to keep current through March 2023.
- c. MOTION to move \$50,000 from tax savings to general to pay bills. Seyfert/Gotto; all ayes
- **10.** Mann Street Project call for bids MOTION to approve the call for bids with the following edits:
  - Bid request specs, last paragraph, replace "the check will be returned" with "the certified/cashiers check or bid bond will be returned"
  - Change #2 on bid tab from 1.5" to 1.25" Gotto/Seyfert; all ayes
- **11. Cyber insurance renewal MOTION –** approve cyber insurance renewal effective April 10, 2023; Seyfert/Gotto; all ayes.
- 12. Open/award road materials and crack filling bids moved to 3a
- **13. NWRB Every other week recycling proposal MOTION** to reject Waste Management Every Other Week recycling proposal. Michalski/Gotto; all ayes.
- 14. Weigel rezone and CSM MOTION accept Weigel CSM and rezone; Seyfert/Michalski; all ayes
- **15. Appoint Board Member to update Personnel Policy -** Opitz volunteered to update the Personnel Policy; **MOTION** to appoint Opitz to update the Personnel Policy; Gotto/Seyfert; all ayes
- **16.** Amend Town Code for Chapter 61 Emergency Services MOTION to amend the code for Chapter 61 Emergency Services as presented with the following addition to Section H: "The chief shall notify the Town Board that a disciplinary action has occurred." Gotto/Seyfert; all ayes; Bauer abstained.
- **17. Tent regulations and permits MOTION** to accept tent regulations as presented but restrict the regulations to only the Town of McMillan and non-residential properties. It is recommended that citizens have tents inspected by the Fire Department; Gotto/Seyfert; all ayes.
