2. BOARD OF REVIEW

NOTICE IS FURTHER GIVEN that the Board of Review for the Town of McMillan shall hold its first meeting to consider assessment objections.

Location: McMillan Town Hall, 113904 Elm Tree Road, Marshfield, WI 54449

Date: August 13, 2025 the Board will convene at 6 p.m. and will be in session for a minimum of two hours.

Please be advised of the following requirements to appear before the Board of Review and procedural information:

- **Notice of Intent:** No person shall be allowed to appear before the Board of Review or contest the amount of any assessment if they have not provided written or oral notice of their intent to file an objection to the Town Clerk at least 48 hours before the Board's first scheduled meeting.
- **Objection Forms:** A formal written objection must be filed with the Town Clerk. Objection forms may be obtained from the Town Clerk.
- Waiver: The Board may grant a waiver of the 48-hour notice requirement if a property owner appears during the first two hours of the meeting, shows good cause for the failure to meet the notice requirement, and files a written objection.
- Mandatory Disclosure: No person may appear before the Board of Review, testify by phone, or object to a valuation if they have refused a reasonable written request by the assessor to view the property's exterior. Furthermore, if the valuation was made using the income method, you must have supplied the assessor with all requested income and expense information.
- **Discussion Recommended:** It is strongly encouraged that you first discuss your assessment with the Town Assessor at the Open Book session before filing a formal objection. Many concerns can be resolved at that stage.

After the Board of Review	s first meeting, it may adjourn to a future date to hear any objections that have been filed.
